School, Prasanthi Nagar, Pendurthi Mandal, Visakhapatnam District,

- That the Society shall abide by the instructions / rules and regulations made by the Govt. or authorized officer from time to time.
- That the Educational Institution shall serve the needs of the locality more particularly. 2.
- That the institution shall adopt the curriculum and syllabus prescribed by the Govt. from time to time. 3.
- That the school timings, vacations and Mid-term holidays shall be as prescribed by Govt. from time to time. 4.
- That the qualified staff within the age limits prescribed by the Govt. for Govt. employees shall be appointed as 5 per the staff pattern.
- 6. That the results of institutions shall be satisfactorily every year.
- That the records/ accounts shall be furnished to the Inspecting Officer every year by 30th September at least. 7.
- That the list of Governing Body shall be furnished to the District Educational Officer every year. 8
- That the pay structure/fee structure fixed by the Governing body shall be got approved by the District 9 Educational Officer every year. 10.
- That all the conditions prescribed in the G.O.s and other orders which are not specified in this order shall be complied with.
- That the school shall not be closed without giving notice both to the parents / District Educational Officer and 11. competent authority at least six months before.
- That the school shall be closed or permitted to be closed only from the date on which summer vacation is 12
- That the society shall submit proposals for renewal of recognition sufficiently in advance i.e. at least six moths 13. prior to the date of expiry of present recognition.
- 14. The school shall follow the traffic and safety guidelines indicted by the traffic police and fire service dept.
- The Parent teachers associations meeting shall be conducted to sensitizes the parents on the safety of the 15, Children.
- The school should have first aid kit and the teachers should be trained in first aid. 16.
- The Management is informed that no thatched roof accommodation is allowed to run the school. 17.
- That the society should provide fire safety measures in the school. 18.
- Wide corridor should provide since the 6 feet corridor is not sufficient. 19.
- Sufficient Place should be provided for conducting daily school Assembly, National Festivals. 20.
- The Management is hereby informed that the Recognition is being given purely on Temporary basis and is subject 21. to the report of State Level Inspection and Vigilance Committee regarding fulfillment of all the pre-requisite conditions under AP Education Act,1982 and if later found, that the school has not fulfilled any pre-requisites as stipulated, the Recognition now being given is liable to be withdrawn at once
